**Offre publique d'acquisition:** Paramount-Finanz AG («**Offrante**») a publié le 16 juin 2008 une offre publique d'acquisition («**Prospectus d'Offre**») pour toutes les actions au porteur en mains du public («**Actions-GRO**») de Growth Value Opportunities SA, Genève, Suisse («**GRO**»).

**Résultat intermédiaire définitif:** A l'expiration de la durée de l'Offre, le 30 juin 2008, 365'528 Actions-GRO ont été présentées à l'offre. Cela correspond à 77.41% des 472'220 Actions-GRO qui se trouvaient en mains du public au moment de la publication de l'offre. Pendant la période de l'offre, l'Offrante a acquis 64'959 Actions-GRO, ce qui correspond à 13.76% des Actions-GRO se trouvant en mains du public au moment indiqué. Au total, le taux d'acceptation s'élève donc à 91.16%.

Compte tenu des Actions-GRO déjà détenues par l'Offrante et par les personnes agissant de concert avec elle avant la publication de l'Offre, le taux de participation de l'Offrante se chiffre au total à 96.66% du capital-actions et des droits de vote de GRO.

**Conditions:** Les conditions de l'Offre sont remplies. L'Offre a donc abouti.
